# L-3 MAS Awarded \$468 Million CF-18 Contract Government of Canada chooses L-3 MAS to maintain its fighter aircraft

MIRABEL, Quebec, September 1, 2010 – L-3 MAS announced today that its maintenance contract for the Canadian Forces CF-18 fleet has been renewed.

In the presence of the Right Honourable Stephen Harper, Prime Minister of Canada, the Honourable Peter MacKay, Minister of National Defence, senior representatives of the Department of National Defence, as well as several employees, L-3 MAS celebrated the award of this new contract valued at \$468 million, which will run from 2010 to 2017, with an option for three additional years. With this award, L-3 has been assigned the task of maintaining Canada's fleet of fighter planes until the end of their life-cycle.

Approximately 400 employees at the company's facilities in Mirabel, Bagotville, Quebec, and Cold Lake, Alberta, will perform the necessary work on this contract.

"As the leading private supplier of aircraft in-service support to the federal government, this announcement is a welcome continuation of a long tradition of cooperation between the DND and L-3 MAS," announced Sylvain Bédard, president of L-3 MAS. For close to 25 years, L-3 MAS has been involved in managing and maintaining the CF-18 Hornet fleet. With the Canadian government's renewed confidence in its unique knowledge and

"Our partnership with the DND has been very solid to date, and we plan to ensure that it continues for a long time," Bédard continued.
